### Document F4: WAIVER AND RELEASE OF LIABILITY

In consideration of being permitted to participate in the above event at my request, I, the undersigned, legally bound myself, my personal representatives (executors/administrators) and my dependents this 12<sup>th</sup> day of JULY, 2019 and I HEREBY RELEASE and DISCHARGE the Singapore Dragon Boat Association ("SDBA"), members of SDBA, fellow participants of the event, SDBA appointed agents, partners and other persons authorised by them, other named and unnamed sponsors, advertisers, owners/lessees of premises for the event, directors of these organisations and volunteers from all claims that I, my personal representatives and dependants may have from any injury (including injury resulting in death) howsoever caused sustained by me and for loss of or damage (howsoever caused) to my personal belongings suffered at any time during or while participating in the event (hereinafter referred to as "releases").

I also acknowledge and undertake as follows:

1. Prior to participating, I will inspect the facilities and equipment to be used, and if I believe anything to be unsafe, I will advise my team manager, coach or sponsor of such conditions and will refuse to participate.
2. I fully understand that myself and each participant will be engaging in activities which involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from my own, but also my actions, inactions or negligence of others, the rules of play, or the condition of the premises or any equipment used. Further, that there may be other risks not known to me or not reasonably foreseeable at this time.
3. I assume all the foregoing risks and accept personal responsibility for the damages following such as injury, permanent disability or death.
4. I have read the rules and instructions of the event and the race.
5. For Parents/Legal Guardians of the Participants under eighteen (18) at time of registration: This is to certify that I, as parent/legal guardian with legal responsibility for this participant, do consent to his/her release as provided above of all the releases and for myself, my child and my heirs, assigns and next of kin, I release and agree to indemnify and hold harmless the releases from any and all liabilities incident to my minor child's involvement or participation in the event, even if arising from the negligence of the releases,

to the fullest extent permitted by law. I have read, understood and intend to be bound by this Waiver and Release of Liability.
