OBJECTIVES OF THE ASSOCIATION

The objectives of the Association are guided by its Vision and Mission.

The Vision of the Association is to develop sporting excellence in the sport of dragon boating and to cultivate mass participation in the sport.

The Mission of the Association is to:

- a. develop and maintain a world class National Team at both senior and junior levels;
- b. develop and promote a comprehensive outreach programme;
- c. develop, promote and maintain world class competition events; and
- d. become an effective agent for dragon boat development.

FUNDING SOURCES

The Association is primarily supported by donations and government grants, revenue from rental of dragon boats, organizing of race events and dragon boating programs/activities.

POLICIES

During the financial year, the Association had updated its Financial Regulations and Human Resource Policy to align with the requirements of the Authorities (MOM, Sport Singapore, etc).

Whistle-blowing policy

Our Association has in place, a whistle-blowing policy to address concerns about possible wrongdoing or improprieties in financial or other matters within the charity.

Safe Sport policy

This new policy was put into place on March 2023 to ensure that all participants in our community play, practice, compete, officiate, work, volunteer and interact in a positive environment that is free from harassment and abuse and that all are aware of their rights, responsibilities and the standards of behaviour expected of those participating in our sport.

MEMBERSHIP

The Association has 109 Ordinary Members, 1 Individual Member and 14 Associate Members as at the date of this report.

THE YEAR IN REVIEW

Review of Financial State

The Association reported a net surplus of \$155,509 for the financial year 2022/23. This was \$128k higher than the net surplus of \$27,304 reported in the financial year 2021/22.

Total revenue including grants and sponsorship was \$1.848 million (FY2022/23) as compared to \$1.187 million (FY2021/22). The resumption of signature local races and client events contributed to the increase of \$661k in total revenue. The rise in boating activities also saw to the growth in boat rental income.

Total expenditure of \$1.693 million incurred in FY2022/23 was \$533k higher than last financial year of \$1.160 million. Expenditure, especially those in relation to events and boating activities, increased in tandem with the upturn in revenue. The National Team also resumed their participation in overseas races in the second half of FY2022/23, leading to the incurrence of overseas travel expenses.

Net assets increased by \$156k from \$795k as at 31 March 2022 to \$951k as at 31 March 2023.

Review of Events & Activities

With Covid-19 finally declared endemic, SDBA's key events returned to the racing scene and were greeted with great enthusiasm by the dragon boat community. Unfortunately, the DBS Marina Regatta will be discontinued as DBS Bank has decided to redirect their focus.

SDBA Singapore Dragon Boat Festival 2022

The Singapore Dragon Boat Festival 2022 was held over 3 days on 3, 4 and 5 June 2022 at Passion Wave@Bedok Reservoir. A total of 2007 participants from 159 racing crews competed in 20 racing categories.

Singapore Regatta Waterfest 2022

The Singapore Regatta Waterfest (SRW) 2022 was held on 26 & 27 November and 3 & 4 December 2022. A total of 3242 participants competed in the 200m DB12 races on the first weekend and in the 200m DB22 races on the second weekend. Participants and supporters were also part of the eye-dotting ceremony to commission the new Champion DB22s with the SRW being the first event to race the boats. The event also incorporated the Hong Kong Cup 2022, in partnership with HKETO, which saw the Hong Kong National squad competing with the winners of the DB22 races categories.

The SDBA Dragon Boat Century Race 2023, in partnership with Passion Wave, kicked off the dragon boat racing calendar for year 2023. A total of 1475 participants competed in 7 racing categories at the Century Race 2023 which was held on 4 and 5 March 2023 at Passion Wave@Jurong Lake Gardens.2

Courses

A total of 4 runs of the SDBA Helm Accreditation Course were conducted between May and December 2022 with some 52 participants certified as steersmen.

High Performance

The 19th Asian Games which was originally to be held in September 2022 in Hangzhou, China had been postponed to September 2023 in view of the on-going Covid-19 pandemic in China.

In view of this, the Men's team took part in the ICF Dragon Boat World Championship 2022 held in Račice, Czech Republic from 1 to 4 September 2022. They came in 4th in the 200 metres event.

Following this, both the Men's and Women's teams competed in the 14th Asian Dragon Boat Championship 2022, held from 19 to 21 December 2022 in Rayong-Pattaya, Thailand. The Women's Team came 4th in the 200 metres event.

The team's effort in both of these race events in 2022 were acknowledged by the Singapore National Olympic Council (SNOC) when they qualified for SEA Games Cambodia 2023. They were also awarded E3P carding status by Sport Singapore, reflecting the recognition of the team's potential towards attaining top 3 in South-East Asian in the next 2 years.

SDBA continues to remain focused on its mission to build and develop the national team, first and foremost to prepare for the SEA Games in Cambodia in May 2023 and the 19th Asian Games to be held in Hangzhou, Zhejiang, China, in September 2023.

We look forward to welcoming more young, promising and committed dragon boat athletes to join us in our journey for sporting excellence, developing especially towards SEA Games 2029, which will be hosted by Singapore.

THE YEAR AHEAD

With Covid-19 declared as endemic, dragon boating saw the return of many teams to their beloved sport. The Association also brought back key events like the Singapore Dragon Boat Festival, Singapore Regatta Waterfest and the SDBA Century Race.

The Association will also continue to raise funds via the Giving.sg platform and looks forward to the continued support from the dragon boat community for its recharged events and activities.

CORPORATE GOVERNANCE AND CONFLICT OF INTEREST

The Association's Management Committee (MC) Members are expected to avoid actual and perceived conflict of interests. Where Members have personal interest in business transactions or contracts that the Association may enter into, or have vested interest in other organizations that the Association have dealings with or is considering entering into joint ventures, they are expected to declare such interests to the MC as soon as possible and abstain from discussion and decision making on the matters. Where such conflicts exist, the MC will evaluate whether any potential conflict of interests will affect the continuing independence of the Members and whether it is appropriate for the Members to continue to remain on the MC.

The Association's MC members are not paid any honorarium or allowances.

STAFF

As at 31 March 2023, there were 9 staff (3 part-time & 6 full-time) employed by the Association and one of 9 staff was attached with the Sport SG.

Mr Raizal Abdol Jalil, General Manager was appointed on 1 July 2016 to helm the Association.

Ms Florence Yong, Event Manager who was attached with the Sport SG is the spouse of Mr Raizal Abdol Jalil, General Manager. Her total annual remuneration for the financial year 2022/23 was between \$50,000 and \$100,000.

The total annual remuneration for each of its three highest paid staff is reported in Note 13 of the Financial Statements.

RESERVES POSITION

The Reserves (Note 10 of the accompanying Financial Statements – Unrestricted Funds) that the Association has set aside provide financial stability and the means for the development of principal activities. The Reserves are intended to be used in the following manner:

- a. daily operating expenses
- b. expenses for major events
- c. repair and maintenance of dragon boats and accessories
- d. training expenses and overseas training/competitions for the National Teams

The Management Committee will perform an annual review of the Reserves to ensure the amounts are adequate to fulfil the continuing obligations for a period of six-months at the least.
